additives.

Additional Information : The highly refined mineral oil contains <3% (w/w) DMSO-

extract, according to IP346.

3. HAZARDS IDENTIFICATION

EC Classification : Not classified as dangerous under EC criteria.

Health Hazards : Not expected to be a health hazard when used under normal
